- With terms and conditions not agreeable to UCFBOT
- Including a named subrecipient in California
- Submitted for certain WUCF-TV or WUCF-FM programs
- Submitted under economic development programs under VP Partnership & Innovation, except UCF Florida SBDC
- With other compelling reasons submitted to Celeste Rivera-Nuñez and Terri Bigham for review and decision
